



## ***2019 Art in the Park at the Fredericksburg Farmers Market***

**APPLICATION:** One (1) annual application shall be submitted for participation as an Art in the Park guest vendor. This application must be submitted NO LATER than close of business on the Thursday before vendor's first event. Application is completed online; please visit our website for the rules and registration links: [www.thefarmersmarket.co](http://www.thefarmersmarket.co). Click *Fredericksburg*, then *Art in the Park*. Upon registration, vendor will be charged the event fee of \$25 for one (1) event. This fee MUST BE PAID PRIOR TO THE EVENT and will be credited towards vendor's participation at that event.

**FEES AND PAYMENT:** The \$25 event fee covers vendor's participation at one (1) event and reserves a 12' x 12' tent space in Hurkamp Park. Artists/Crafters without a City of Fredericksburg Business License are required to pay an additional \$10 fee for each event attended; this is for the required City Event Fee in lieu of the Business License. In short, total fee for one (1) event will either be: \$25 *with* vendor's own Business License, \$35 *without* vendor's own Business License. Payment to participate is due NO LATER than close of business on the Thursday before the event. This reserves a set-up space for the vendor on the day(s) chosen and paid for. **Payment(s) may be submitted: in person at the Dorothy Hart Community Center (408 Canal St., Fredericksburg VA 22401), by mail, with credit card (540-372-1086, dial extension 0), or through the PayPal link on the application website.**

**AVAILABLE DATES:** May 4 & 18, June 1 & 15, July 6 & 20, August 3 & 17, September 7 & 21, October 5 & 19, 2019. Art in the Park is a rain or shine event in conjunction with the Farmers Market. The City of Fredericksburg holds the discretion to cancel one or more of these events. Fees are non-refundable if vendor misses scheduled event; fees may be refunded only if event is cancelled by the City.

**STANDARDS:** **All work must be the original fine art or craft created by the exhibiting artist.** The artist/crafter creating the works is expected to be present during event. Vendor is responsible for all display equipment, set-up, tents, chairs and tables; NO MATERIALS, electrical or any other item, will be provided by Fredericksburg Parks, Recreation, & Events, Public Facilities, or the City. Vendor takes full responsibility for the safety of themselves, their family, helpers, belongings, and works. Vendor agrees to release and hold harmless the Fredericksburg Parks, Recreation, & Events, Public Facilities, as well as the City of Fredericksburg and its employees/volunteers from any and all liability.

**MEDIUMS OFFERED HAVE INCLUDED:** ceramics/pottery, graphics/printmaking, painting, jewelry, photography, drawing/pastels, metal work, sculpture, fiber/leather, mixed media, wood, glass, 3-D printing, candles, soaps, etc.

**EVENT DAY:** Advertised hours are 9:00 AM to 1:00 PM at Hurkamp Park, William and Prince Edward Streets, downtown Fredericksburg, VA. Artists may arrive at 6:00 AM or later to begin setting up. Sales after 7:00 AM are permitted. **There is no parking lot for Hurkamp Park. Parking available on streets and in lots adjacent to the market. Only unload at the alley west of the Park or from a legal parking space. No driving in Park. Register with the Market Manager upon arrival. The Market Manager will request to review a copy of vendor's current Business License, when applicable. The Market Manager has the authority to ask guest participants to leave or to refuse an application.**
